### **What information do we collect about you?**

We collect your Personal Data when you provide any information to us by sending e-mail messages to the addresses mentioned on this website.

By submitting your Personal Data to us by sending us e-mail messages, you will be treated as having given your consent for the processing of your Personal Data as set out in this Privacy Notice.

### **For what purposes do we collect your Personal Data?**

We may collect and use users' Personal Data to respond to your inquiries, questions, or other requests.

We will not share or sell your Personal Data with third parties for marketing or other purposes.

We will not use your Personal Data for other purposes than those stated in this Privacy Notice.

The legal basis for the processing of your Personal Data is your consent. You have the right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

We may disclose your Personal Data to Sogelis S.a.r.l. for the purposes of database maintenance. Sogelis S.a.r.l. will access your Personal Data only to perform tasks on our behalf in compliance with this Privacy Notice, and we will remain responsible for their handling of your Personal Data as per our instructions.

### **What are your rights?**

You can ask us whether we are keeping Personal Data about you at any time and you can also request to access your personal information and to receive a copy of it within 30 calendar days after the request is made. Your Personal Data may, upon request, be provided in a structured, commonly used and machine-readable format.

You can request us to supplement, update or rectify your Personal Data in our records. You can also request the deletion of such information, or restriction of processing and, where technically feasible, the transmission of your data directly to another controller of your choice (right to data portability).

You have the right to ask us not to process your Personal Data for marketing purposes. We will always inform you (before collecting your data) if we intend to use your data for such purposes or if we intend to disclose your information to any third party for such purposes.

You have the right to lodge a complaint with the supervisory authority (Autorité de protection des données - APD) to safeguard your rights of Personal Data protection.

### **How do we protect your Personal Data?**

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information.

We use a third party service, Lamano S.a.r.l, to help maintain the security and performance of the EUCOLAIT website.

### **How long is your Personal Data retained?**

The information collected from our website users will be retained by us for a maximum duration of 5 years.
